To **GUINN OUTFITTERS LTD.**, (hereinafter referred to collectively as "The Company") and employees, representatives, officers and agents (hereinafter referred to collectively as "The Company" Employees).

1. I agree as a precondition to my participation in a trail ride, wagon/sleigh ride or hunting activities, organized by "The Company" and conducted by "the Company" and/or "The Company" Employees, and in further consideration of "the Company" allowing me to do so, to be strictly bound by the terms of this Waiver, Assumption of Risk and Indemnity Agreement (hereinafter referred to as "This Agreement").
2. I acknowledge that trail rides, wagon/sleigh rides or hunting activities involve **INHERENT RISKS** that may cause **SERIOUS INJURY AND POSSIBLY DEATH TO PARTICIPANTS**. I further recognize that backcountry trail, horse, wagon/sleigh rides and hunting activities involve **ADDITIONAL RISKS AND DANGERS**.
3. I fully understand the risks and dangers associated with my participation in this wagon/sleigh, trail ride or hunting activities and **ACCEPT SAME ENTIRELY AT MY OWN RISK**.
4. I hereby **WAIVE ANY AND ALL CLAIMS** which I may have against "The Company" and "The Company" Employees and **RELEASE "The Company" And EMPLOYEES** from **ALL LIABILITY** for injury, death, property damage or any other loss sustained by me as a result of my participation in this wagon/sleigh or trail ride or hunting activity, **DUE TO ANY CAUSE WHATSOEVER** including, without limitation, negligence on the part of "The Company" and "The Company" Employees. I further **AGREE TO INDEMNIFY "The Company" and "The Company" Employees** for any and all legal fees (on a solicitor and his own client basis) or costs which may be incurred in defending any lawsuit or claim I may bring against them. I agree that any legal actions must be undertaken in same jurisdiction as trip took place.
5. I appreciate that "This Agreement" applies whether "The Company" is at fault or not and it limits the liability of "The Company" Employees to the same extent as it limits the liability of "The Company" even though "The Company" Employees are not formal parties to this agreement. I understand that "The Company", in securing execution of "This Agreement" by myself, is acting as agent or trustee on behalf of or for the benefit of "The Company" Employees, who shall to this extent be or be deemed to be parties to "This Agreement".
6. I agree to give up any right or claim to compensation for the use by "The Company" for promotional purposes, any photographic image/video taken of me during any tour or activity with "The Company" or when on its premises.
